Construction of logistics warehouse development project in Northern Vietnam "Sembcorp Logistics Park (Hai Duong)" has begun on the 10th of September 2021

Hankyu Hanshin Properties Corp. (Head office: Kita-ku, Osaka; President: Morotomi Ryuichi) and CRE Inc. (Head office: Minato-ku, Tokyo; President: Kameyama Tadahide), jointly with Sembcorp Development Ltd. (SCD)* of Singapore are carrying out the development and operation of logistic warehouse in VSIP Haiphong integrated town/ industrial park in Northern Vietnam under the joint-venture company Sembcorp Infra Service Pte. Ltd. (SIS).

We are proud to announce that the construction of "Semcorp Logistics Park (Hai Duong), located in VSIP Hai Duong Industrial Park in Northern Vietnam has begun on 10 September 2021.

This project is expected to be completed around the spring of 2022. Upon completion of this projects, it marks the fourth logistics center being owned and managed by Sembcorp Infra Service, in addition to the three warehouse assets located in Hai Phong. The total net leasable area amounts will be approximately $56,000 \, \mathrm{m}^2$.


