This strategic move involves a joint logistics real estate development project (hereinafter referred to as the" Project") in the Atlanta metropolitan area, partnering with companies such as Trammell Crow Company and CBRE K.K. The project is also backed by investments from Keihanshin Building Co., Ltd. and Nippon Steel Kowa Real Estate Co., Ltd.

The Atlanta metropolitan area\* is notable for its high growth potential, with population and GDP growth rates surpassing the national average. Moreover, the area boasts significant transportation infrastructure, including Hartsfield-Jackson Atlanta International Airport, which holds the record for the highest number of takeoffs and landings globally. This makes Atlanta the fourth-largest logistics market in the United States.

The Project's site is strategically located approximately 70 km northeast of downtown Atlanta, providing excellent access to Interstate Highways I-985 and I-85. This prime location is expected to meet the logistics needs for storage warehouses and distribution centers catering to e-commerce and consumer goods, suggesting robust demand for logistics real estate.

\*The Atlanta metropolitan area, as defined by administrative authorities, refers to a region centered around the city of Atlanta that exhibits economic interrelations across the entire area.


In 2022, we established HHPUSA and have since advanced five multi-family apartment projects. Moving forward, we are committed to continually expanding our real estate business in the United States.
