# Announcement regarding start of construction for Sembcorp Logistics Park Thuy Nguyen (Hai Phong)

 $\sim$ Construction of a logistics warehouse in VSIP Haiphong Industrial Park has started. $\sim$ 

Hankyu Hanshin Properties Corp. (Head Office/Kita-ku, Osaka – President/ Yasuki Fukui) and CRE, Inc. (Head Office/Minato-ku, Tokyo – President/ Tadahide Kameyama), together with Singapore-based Sembcorp Development Ltd.\*, have invested in Sembcorp Infra Services Pte. Ltd. (SIS) to develop and operate logistics warehouses in northern and central Vietnam.

We are pleased to announce that the three companies have jointly commenced the construction of Sembcorp Logistics Park Thuy Nguyen (Hai Phong) - a two-story logistics warehouse in the VSIP Hai Phong Industrial Park in northern Vietnam through investment into SIS.

We aim to complete this project in September-October, 2025, Once completed, the total number of logistics warehouses developed and operated by SIS will be 11 properties, including 5 properties in northern Vietnam (4 properties in Hai Phong and 1 property in Hai Duong), and 6 properties in central Vietnam (3 properties in Quang Ngai and 3 properties in Nghe An), with total net leasable area up to approximately 150,000 m<sup>2</sup>.

\*\* Sembcorp Development Ltd. has nearly 30 years of experience in developing industrial parks in Asia. It is a subsidiary of Sembcorp Industries Ltd. which is a Temasek-linked company (Temasek Holdings), an international investment company owned by the Singapore government. Temasek Holdings also invests in a wide range of businesses including finance, telecommunications, media, technology, transportation, real estate, energy, and natural resources.




External view of the warehouse
